THE EXECUTIVE SECRETARY ANNOUNCES THE COMMENCEMENT OF

The Last Phase of the Verification Exercise for Civil Service Pensioners under the Defined Benefit Scheme (DBS) in the North Central Zone

The Pension Transitional Arrangement Directorate (PTAD), will commence its last phase of verification for Civil Service Pensioners in the North Central Geo-political Zone of the Federal Republic of Nigeria beginning in **Kogi, Benue, Plateau and Kwara States from 6th-11th November, 2017**, followed by **FCT, Niger and Nasarawa States from 11th-16th December, 2017**.

Civil Service Pensioners are to come along with both originals and photocopies of their employment records.

The following documents and information are mandatory for all pensioners:

1. Letter/Gazette of First Appointment
2. Letter/Gazette of Confirmation of Appointment.
3. Letter/Gazette of Last Promotion.
4. Letter/Notice of Acceptance of Retirement from by a Competent Authority
5. Evidence of Change of Name (Where Applicable).
6. Approval Letter for Condonation/Merger of Services from the Head of Service of the Federation (where Applicable)
7. Record of Service
8. Bank Verification Number (BYN)
9. Duly stamped and signed NUBAN Bank Statement of Account with the Bank Logo showing the last 12 months of activity.
10. Valid Means of Identification (Driver's License, International Passport, National Identity Card or Voter Identification Card)
11. 1 Coloured Passport Photograph
12. **All Pensioners with complaints of non-enrollment, non-payment or short payment must provide a duly stamped and signed NUBAN Bank Statement of account with the Bank Logo showing activity from date of retirement or 6 months before the complaint, till date.**

The under-listed additional documents and information are required for the following categories of pensioners:

- Due Pensioners Birth Certificate/Sworn Affidavit of Age

- Disengaged Retirees Evidence of Payment of Gratuity Severance Pay Slip
- State Pensioners with Federal Share Computation Sheet duly stamped and signed by the State Auditor General
- Steel Rolling Mills Pensioners Duly stamped and signed NUBAN Bank Statement of Account with the Bank Logo showing the last 12 months' payments of state share of monthly pension Computation Sheet
- Retired Federal Permanent Secretaries and Heads of Service of the Federation Letter of Appointment as a Head of Service of the Federation or Federal Permanent Secretary either from the Secretary to the Government of the Federation, or the Head of the Civil Service of the Federation

For the Next of Kin (NOK) of Deceased Pensioners, the following documents are essential:

1. Death Certificate of the Deceased from a Government recognized hospital.
 2. Letter of Administration
 3. Joint Application Letter by the NOK(s), as listed on the Record of Service.
 4. Marriage Certificate (for Spouses)
 5. Duly signed and stamped NUBAN Joint Bank Account Statement of the NOK(s), with Bank Logo
 6. 1 Coloured Passport Photograph for each NOK
 7. NOKs to deceased State Pensioners with Federal Share must provide the deceased's Record of Service.
 8. Valid Means of Identification (Driver's License, International Passport, National Identity Card or Voter Identification Card)
- Mobile Verification will be conducted for sick and infirm Pensioners. Please contact PTAD through the toll-free **0800-CALL-PTAD (0800-2255-7823)** for special arrangement to be made.
- Security Agencies will be at the venues. FRAUDSTERS BEWARE.
