She expressed confidence in the effectiveness of the ACTU in furthering the Directorate's mission to institute best practice in pension administration and prevent corrupt practices.

"I have the utmost confidence in the ability of the members of the ACTU to spearhead the building of a culture of accountability, transparency and professionalism.

"Pension Management is indeed in need of change, and that change will begin with us here at PTAD, as we continue to improve the welfare of all pensioners under the defined benefit scheme.'



PTAD RESTATES COMMITMENT TO NORTH-EAST PENSIONERS' VERIFICATION

The Executive Secretary (ES) of the Pension Transitional Arrangement Directorate (PTAD) Sharon Ikeazor, has restated the Agency's commitment to verifying pensioners in the North-East region of the country as a way of keying into the Federal Government's plan to rehabilitate the insurgency-ravaged area.

Ikeazor said this while briefing the House of Representative Committee on Pension on the 2016 Pension Budget Implementation and Performance

Responding to issues raised by Chairman of the Committee, Hon. Adamu Shekarau, the ES noted that the issue of verification is important to the sanitization of the database of pensioners under the Defined benefits Scheme (DBS).

She stated that PTAD had from 2015 conducted the verification of the Police. Customs. Immigration and Prison Pensioners and commenced the verification of Civil Service Pensioners, beginning with the North-West Zone (Jigawa, Kano, Kebbi, Sokoto, Katsina, Kaduna and Zamfara) and followed by the South-East Zone (Enugu, Anambra, Imo, Abia and Ebonyi), adding that plans are ongoing for the verification of the remaining Zones, starting with the North East.

"We are already planning for the remaining zones which are the North-East, South-South, South-West and North Central," she said.

"We are starting with the North-East, before the end of this year, as we want to key into the federal Government's vision of rebuilding the North-East."

The ES also reiterated her vision of making access to pensions and other entitlements a dignifying experience for pensioners under the DBS.

"No pensioner must suffer to get their pension. We must treat them with dignity and empathy and that is what we have been doing at PTAD.

"Under my watch, we will improve on that."

It will be recalled that Ikeazor had last Tuesday unveiled the plans to commence verification in the North-East when she led members of her management team on a courtesy visit to Director General of the National Orientation Agency (NOA), Dr. Garba Abari.
